

Puppy Health Guarantee & Bill of Seventy-Two Hour Guarantee

This puppy is being sold, to the best of the Breeder's knowledge, to the Buyer in a healthy state. This puppy has a seventy-two (72) hour guarantee, after the delivery date _____, in the case of communicable disease (Parvo, Distemper, and Giardia). The Breeder does not guarantee the puppy against illness brought on by the stress of moving (from our house to yours) shipping, or motion sickness resulting from being transported. This stress can ignite illnesses such as Hypoglycemia (sugar drop) or Coccidiosis (dormant in most live animals). The onset of Coccidiosis can happen hours after a stressful event and does not reflect a good or bad breeder. Breeder does not guarantee the puppy to be "worm free," as this is an ongoing process that, once the animal is out of our control, is the responsibility of the Buyer. The seventy-two (72) hour guarantee covers only the puppy itself. It does not cover any veterinarian bills or any other animal that it has come into contact with or any other cost incurred. After this time, it is the Buyer's responsibility for these diseases.

One Year Health Guarantee

This puppy (female/male) _____ has a one (1) year health guarantee, from the delivery date of _____, against any congenital disorders that are fatal and cannot be taken care of by medicine or antibiotic. If such a case is detected, and is diagnosed in writing by a qualified veterinary specialist, the Breeder will replace the puppy with another puppy of the same breed, or a refund of the purchase price _____ upon the return of the dog at the Buyer's expense. The Buyer must notify the Breeder within forty-eight (48) hours of diagnosis. The Breeder is not responsible for any vet bills incurred by the Buyer. The Buyer has fourteen (14) days from the day of pickup or delivery to take the puppy to a licensed veterinarian for a check-up for the contract to be valid. The Buyer must be able to produce a signed and dated receipt and medical records from the veterinarian. If the puppy is not taken to the veterinarian within the fourteen (14) days, then this contract is void.

This contract does not include medical expenses, mortality, landlord's disapproval, allergy to puppy, disagreeing of family members, temperament of the puppy, shedding, or any other reason the puppy is not wanted, unless stated in this contract.

This contract is not transferable and is void if the puppy is sold, traded, or given away, etc. This contract is also void if the Buyer does not keep up with schedule immunizations. Veterinarian receipts must be kept and provided to prove this.

If the Buyer wishes to return the puppy under the Breeder's Health Guarantee, the Buyer agrees to return the puppy to the Breeder at the Buyer's expense and to assume the cost of shipping the replacement puppy, if shipping is required. If the Buyer does not pick up the puppy and has another authorized person pick it up, or if the puppy is shipped, the Buyer has five (5) days to send the contract back signed and dated, or the contract is void. The Buyer has 48 hours to contact the Breeder of anything covered under this contract, otherwise the contract is void.

The Breeder is not responsible for the puppy once it leaves the Breeder's care, except what is written in this contract. If the puppy is transported by airplane, the Breeder will purchase insurance on the puppy for transport. Once the Buyer signs for the puppy, at the airport pickup point, the Buyer releases the airline of any harm to the puppy. The Buyer is also responsible for any and all expenses of additional surcharges during the transport of the puppy. This includes, but is not limited to, holding fees, special veterinarian fees, etc.

It is further understood and agreed that no warranty or representation has been made with respect to the sold animal, except in writing in this agreement. The Breeder assumes no responsibility for any of the Buyer's veterinarian bills. If any legal fees are incurred from this transaction, then the Buyer assumes all the Breeder's fees.
